Expanding on this a little, I believe her name is [REDACTED] – or at least that's how she's listed on travel records. We have a breakdown of airline tickets purchased with any AmEx card associated with Epstein, which is how he primarily booked flights for others (which he did constantly; we have records of more than 4,800 flights that he purchased in the past ten years). There are hundreds of flight ticket records for [REDACTED] dating from 2011 up to as recently as last month.

Let us know if you want those records; the file is too big to email, but we can add you to the share drive or I can put it in the share of a case that [REDACTED] and I have together so you can pull it over to your share if you have a different one and want a separate copy.
