Mike,

I just tried calling, but I realize it's very late — moments ago I spoke with an individual at the Office of the Chief Medical Examiner, Dr. Jason Graham. He said his office was in touch with the family today — I believe Mark — and he had the understanding a pathologist was lined up for tomorrow, but based in the newer understanding that you conveyed, that more time is needed, they are prepared to delay tomorrow the autopsy (which was otherwise planned for tomorrow morning). Hey conveyed that permitting a pathologist is a courtesy they extend in this type of situation, and that an additional day or two will not have an effect in their ability to evaluate the cause and manner of death.

Accordingly, he asked that you please contact him tonight or tomorrow morning to arrange logistics of the pathologist who ultimately will join; Dr. Graham's e-mail is:

As of tonight, my understanding is that he has instructed his staff not to proceed tomorrow morning, pending being in touch with you for further coordination.

Please let me know if there are any issues being in contact with him, and also feel free to contact me generally if that would be helpful.

Following up on my conversations with Mike and Marty this morning, and my discussion with Mike moments ago, attached is a press release just sent to us (and I believe also issued publicly) some minutes ago. It represents all the information we have from BOP so far, but of course if we are successful in our continuing efforts to get additional information we will pass it along immediately.

Separately, we can tell you that the reports that an FBI investigation into the death has been initiated are accurate, and I fully expect that investigation to be extremely rigorous.
