With apologies for bothering you with this, we have hit just a complete brick wall with the FBI Information Management Division person we're interacting with, attempting to get a copy of their scans of the FBI case file – the below emails are the first and then most recent email communications we've had with her, but in between are at least a dozen other unreturned emails and phone calls since January, from both me and [REDACTED]. [REDACTED] is perfectly pleasant when we're able to connect with her, but everything is always a "few days" from being done, which then turns into weeks on end.

I'd like to enlist the help of someone with more influence than we seem to have at the line level—I'm happy to call the DAAG who offered to help if we had any logistical issues, or alternatively the only other person I can identify online as having supervisory authority at IMD is [REDACTED], whom I'm happy to contact, but he's an Assistant Director, so it would be jumping many layers of command. So wanted to check with you on what you think would be most appropriate in terms of elevating?

Happy to discuss in person if that's useful, and thanks very much for the help.
