[REDACTED] [REDACTED] had said a few weeks ago, in response to a CBS inquiry that I let them know about, that there's no 'new' investigation, but [REDACTED] and colleagues are hearing there has been recent activity in the ongoing inquiry. I asked [REDACTED] about this Times inquiry (see below), but I haven't heard back. I'm happy to provide whatever guidance you think appropriate. [REDACTED] asking because he wants to keep his pledge not to discuss business when you meet.
