Receipt of Information from [REDACTED], Facility Manager, Federal Bureau of Prisons

On October 1, 2021, through March 10, 2022, Assistant Special Agent in [REDACTED], U.S. Department of Justice Office of the Inspector General (OIG), received the attached emails from Facility Manager [REDACTED] Federal Bureau of Prisons (BOP), Metropolitan Correctional Center (MCC), New York, New York. [REDACTED] was interviewed by the OIG on August 4, 2021, in reference to an official OIG investigation into the events surrounding the death of BOP inmate Jeffrey Epstein, Register Number 76318-054, who was previously housed within the MCC New York. [REDACTED] was the Facility Manager at the MCC New York when Epstein was housed within the MCC New York. The emails received from [REDACTED] were in reference to the topics discussed during [REDACTED] interview, and are in specific reference to the MCC New York camera system. The interview of [REDACTED] is documented within a separate Memorandum of Investigation.
